# Biddeford Police Department NARRATIVE FOR DETECTIVE ROBERT W PERKINS

Ref: 18-824-OF

On 04/02/18, at 0833hrs, Biddeford's Emergency Communications Center began receiving multiple reports of a building on fire at 45 Hill Street. Biddeford Fire and police units were immediately dispatched to the scene. The structure involved was a three-story, multi-unit apartment building. The fire continued to intensify, requiring additional fire departments (five alarms) to respond with equipment and manpower to help suppress the blaze.

I was assigned to assist Maine Fire Marshal Mark Roberts and his team with the investigation. Through investigation, Detective Quarles and I were able to identify and locate the tenants who were known to have been currently residing in the apartment building at 45 Hill Street. In doing so, we we able to account for the current whereabouts of all but one of the tenants, 88-year old Arnold Goldman of apartment #101.

During the investigation, it was learned from Mr. Goldman's friend and roommate, Donna Miller, that Arnold was taking a shower when she left the apartment that morning to bring her daughter to school, and that when she returned approximately 20 minutes later, the building was on fire. Donna at first tried to enter their apartment via the front entrance, but the intense heat and smoke prevented her from doing so. She then went to the rear of the building and again attempted to enter the apartment to look for Arnold. Due to the smoke and heat she was unable to enter.

Once the fire was fully extinguished, it was determined that the structural integrity of the building was such that it was too dangerous to enter and conduct a search. The Fire Marshal's Office contacted a contractor who responded to the scene with excavation equipment and began to systematically extract material from the left side (rear) of the structure and moving forward, initially working toward uncovering what remained of apartment #101. During the excavation process, the body of a male was recovered amid the debris of apartment #101. The body was badly burned, making an immediate positive identification impossible.

Evidence Technician Matthew Baldwin photographed the scene, to include the excavation portion and body photos.

Notification of the Medical Examiner's Office was handle by the the Fire Marshal's Office. Dennett, Craig & Pate Funeral Services were contacted and did respond and remove the body from the scene.

Biddeford Code Enforcement personnell were on scene and determined that, in the interest of public safety, the entire structure needed to be immediately demolished. Additional equipment was subsequently requested and did respond to tear down the building.

I have requested a copy of the Fire Marshal's Investigative Report. When it becomes available, I will attached it to this case report.
