

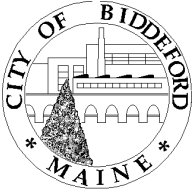



The City reviewed available records and found no data relative to your request for information on the subject property or a spill that reportedly occurred in 2002 when the subject property was occupied by Biddeford Blanket Company.
